## **Course Description**

This course reflects PLNU's commitment, as a Christian university of the liberal arts and professions, to nurture an appreciation for Scripture as the basis for creative personal faith and human life in the modern world. It is designed to foster knowledge and understanding of the literature and history of the Bible and to integrate faith, learning, and living from a Wesleyan perspective.

- 1. To recognize the central role of Jesus, as the fulfillment of the Old Testament hope for the future, and as the focus of the faith of the New Testament Church.
- 2. To outline the general contents of the Bible, including major events of biblical history and flow of the biblical narrative.
- 3. To identify, summarize and discuss major themes and virtues of the Bible and their continuing relevance for Christian faith and life.
- 4. To reflect on and articulate how certain key biblical concepts influence contemporary practice in students' social environments including family, work, relationships and global settings.
- 5. To undertake an in depth study of the Book of Philippians, identifying and reflecting in writing upon its major themes and the central role of Jesus in believers' lives and in the church.

Incompletes will only be assigned in extremely unusual circumstances.

# **PLNU Attendance and Participation Policy**

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. Therefore, regular attendance and participation in each course are minimal requirements.

If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university withdrawal date or, after that date, receive an "F" grade.

In online classes students who do not attend at least once in any 3 consecutive days will be issued an attendance warning. Students who do not attend at least once in any 7 consecutive days will be dropped from the course retroactive to the last date of recorded attendance.

Students who anticipate being absent for an entire week of a course should contact the instructor in advance for approval and make arrangements to complete the required coursework and/or alternative assignments assigned at

the discretion of the instructor. Acceptance of late work is at the discretion of the instructor and does not waive attendance requirements.

### Synchronous Attendance/Participation Definition

For synchronous courses that have specific scheduled meeting times (including in-person, hybrid, and synchronous online courses), absences are counted from the first official meeting of the class regardless of the date of the student's enrollment. For courses with specific attendance requirements, those requirements are outlined in the course syllabus.

**Note**: For synchronous courses with an online asynchronous week, refer to the Online Asynchronous Class Attendance policy listed below.

### Online Asynchronous Attendance/Participation Definition

Students taking online courses with no specific scheduled meeting times are expected to actively engage throughout each week of the course. Attendance is defined as participating in an academic activity within the online classroom which includes, but is not limited to:

- Engaging in an online discussion
- Submitting an assignment
- Taking an exam
- Participating in online labs
- Initiating contact with faculty member within the learning management system to discuss course content

**Note:** Logging into the course does not qualify as participation and will not be counted as meeting the attendance requirement.

## **Course Modality Definitions**

- 1. Online Courses: These are courses with class meetings where all instruction and interaction are fully online.
  - 1. Synchronous Courses: At least one class meeting takes place at a designated time.
  - 2. Asynchronous Courses: All class meetings are asynchronous.
- 2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- 3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).
