#### **COURSE DESCRIPTION**

Focuses on the social scientific study of dyadic (two-person) communication. Opportunities are given to integrate theory and practice in an effort to stimulate self-awareness and highlight taken-for-granted aspects of interpersonal communicative behavior.

#### **COURSE LEARNING OUTCOMES**

- 1. Explain theories and concepts of interpersonal communication and apply these concepts to personal relationships.
- 2. Identify the guiding principles of Nonviolent Communication and apply this communication process/language to your relationships, workplaces, and communities.

- 3. Distinguish empathetic communication from other forms of non-empathetic communication and demonstrate empathic communication to both self and others.
- 4. Evaluate the positive and negative effects of communication behaviors and their impact on close relationships.
- 5. Self-reflect and assess your own communication behaviors in relationships through journaling and sharing in a supportive group environment.

- 1. Learning, Informed by our Faith in Christ Students will acquire knowledge of human cultures and the physical and natural world while developing skills and habits of the mind that foster lifelong learning.
- 2. **Growing, In a Christ-Centered Faith Community** Students will develop a deeper and more informed understanding of others as they negotiate complex professional, environmental and social contexts.
- 3. **Serving, In a Context of Christian Faith** Students will serve locally and/or globally in vocational and social settings.

# PLNU ATTENDANCE AND PARTICIPATION POLICY

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. Therefore, regular attendance and participation in each course are minimal requirements.

If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university withdrawal date or, after that date, receive an "F" grade.

#### Synchronous Attendance/Participation Definition

#### **Online Asynchronous Attendance/Participation Definition**

Students taking online courses with no specific scheduled meeting times are expected to actively engage throughout each week of the course. Attendance is defined as participating in an academic activity within the online classroom which includes, but is not limited to:

- Engaging in an online discussion
- Submitting an assignment
- Taking an exam
- Participating in online labs
- Initiating contact with faculty members within the learning management system to discuss course content

**Note:** Logging into the course does not qualify as participation and will not be counted as meeting the attendance requirement.

#### **COURSE MODALITY DEFINITIONS**

- 1. Online Courses: These are courses with class meetings where all instruction and interaction are fully online. 1. Synchronous Courses: At least one class meeting takes place at a designated time.
  - 2. Asynchronous Courses: All class meetings are asynchronous.
- 2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.

3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).
