- 2. Apply and examine basic theory for strategic communication.
- 3. Learn and evaluate empathic listening skills to increase success in a strategic communication environment and beyond.
- 4. Evaluate the personality of brands and develop an understanding of how they connect with their target audience, including storytelling.
- 5. Display verbal and nonverbal communication skills in interpersonal and organizational contexts.
- 6. Examine ethics in strategic communication with an integration of Christian worldview, including an ethical framework for Artificial Intelligence.

ASSESSMENT AND GRADING

This course uses weighted grades. Assignment categories are worth the following percentages of the total course grade:

- **Discussions** (18%) In most weeks, you will participate in discussion forums where you will discuss the week's readings with your classmates. Note: These discussions are distinct from project milestones with discussion elements.
- **Project Milestones** (15%) You will work on components of your project in several "milestone" assignments throughout the course.
- **Journals** (20%) Each week you'll compose a personal, reflective response to that week's readings and/or topics.
- **Quizzes** (10%) You will complete 4 reading quizzes and 3 required PLNU surveys.
- **Final Project** (37%) You will create a final presentation where you "pitch" an idea as you would pitch to a client.

PLNU ATTENDANCE AND PARTICIPATION POLICY

Synchronous Attendance/Participation Definition

Online Asynchronous Attendance/Participation Definition

Students taking online courses with no specific scheduled meeting times are expected to actively engage throughout each week of the course. Attendance is defined as participating in an academic activity within the online classroom which includes, but is not limited to:

- Engaging in an online discussion
- Submitting an assignment
- Taking an exam
- Participating in online labs
- Initiating contact with faculty member within the learning management system to discuss course content

Note: Logging into the course does not qualify as participation and will not be counted as meeting the attendance requirement.

COURSE MODALITY DEFINITIONS

- 1. Online Courses: These are courses with class meetings where all instruction and interaction are fully online.
 - 1. Synchronous Courses: At least one class meeting takes place at a designated time.
 - 2. Asynchronous Courses: All class meetings are asynchronous.
- 2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- 3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).
