Course Description

This course introduces major concepts of social research, provides skills to understand research results; awareness of influence of social and legal parameters of ethical research; opportunity to analyze and apply research in the criminal justice arenas, identify research strategies to promote social/economic justice.

Assignment Category	Description	Percentage of Total Grade
Discussions	Each week students will participate in online discussions with classmates, which are related to the week's readings and content. These discussions replace the interactive dialogue that occurs in the traditional classroom setting.	30%
Quizzes	There are pre-week and post-week quizzes in this course. These quizzes are taken from the content/readings provided each week within the course.	15%
Assignments	Each week has written assignments and activities. These assignments must reflect college-level writing and critical thinking and include synthesizing reading and analyzing fact patterns (scenarios).	30%
Final Project	Everything you have learned in this course will help you be successful in this assignment.	25%

Student grades for assignments will be posted in the Canvas gradebook no later than midnight on Tuesday of each week beginning in Week Two of this course. Online Asynchronous Attendance/Participation Definition

Course Modality Definitions

- 1. Online Courses: These are courses with class meetings where all instruction and interaction are fully online.
 - 1. Synchronous Courses: At least one class meeting takes place at a designated time.
 - 2. Asynchronous Courses: All class meetings are asynchronous.
- 2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- 3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).
