### **Course Description**

This course focuses on the relationship of the human nervous system to performance of occupations. Specific neurological systems covered will include sensory, motor, limbic, cognitive, visual, and vestibular and ventricles that correlate to common conditions seen by occupational therapists. Cases and lab experiences will assist the student in integrating neurologic concepts.

Prerequisite(s): Successful completion of ANA 6000, ANA 6001, or ANA 6005/ANA 6005L. ANA 6005/ANA 6005L is required for students in the MS Occupational Therapy program.

Successful completion of this course is necessary to progress to OCC 6027.

### **Relationship of Course to Curriculum Design**

This course is the 2<sup>nd</sup> in a 2-part basic science series. It is taken concurrently with the following courses: OCC 6007, Human Occupations Across the Lifespan, OCC 6008, Applied Human Movement, OCC 6008L, Applied Human Movement Lab; OCC 6010, Research Methods-1; OCC 6011, Mental Health Conditions, Assessments, and Interventions; OCC 6011L, Mental Health Conditions, Assessments, and Interventions Lab, and OCC 6012, Case-Based Learning Seminar-2. This course supports the curricular thread of occupation. The foundational knowledge gained in the course prepares students to succeed in OT coursework across the curriculum.

Class topics are discussed for the sole purpose of expanding your intellectual engagement in the occupational therapy profession, and I will support you throughout your learning in this course.

### **Trigger Warning**

I acknowledge that each of you comes to PLNU with your own unique life experiences. This contributes to the way you perceive several types of information. In Applied Neuroanatomy, we will cover a variety of topics, some of which you may find triggering. These topics include viewing human prosections from human cadavers, and discussion of various neurological disorders Each time this topic appears in a reading or unit, it is marked on the syllabus. The experience of being triggered versus intellectually challenged are different. The main difference is that an individual must have experienced trauma to experience being triggered, whereas an intellectual challenge has nothing to do with trauma. If you are a trauma survivor and encounter a topic in this class that is triggering for you, you may feel overwhelmed or panicked and find it difficult to concentrate. In response, I encourage you to take the necessary steps for your emotional safety. This may include leaving class while the topic is discussed or talking to a therapist at the Counseling Center. Should you choose to sit out on discussion of a certain topic, know

that you are still responsible for the material; but we can discuss if there are other methods for accessing that material and for assessing your learning on that material. Class topics are discussed for the sole purpose of expanding your intellectual engagement in the profession of occupational therapy, and I will support you throughout your learning in this course.

### **PLNU Course Modality Definitions**

1. Online Courses: These are courses with class meetings where all instruction and interaction is fully online.

- a. Synchronous Courses: At least one class meeting takes place at a designated time.
- b. Asynchronous Courses: All class meetings are asynchronous.
- 2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- 3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

## **PLNU Attendance and Participation Policy**

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. Therefore, regular attendance and participation in each course are minimal requirements.

If the student is absent for more than 10 percent of class sessions, two classes for a 16-week course and 1 class for a quad course, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university withdrawal date or, after that date, receive an "F" grade.

Students who anticipate being absent for a class should contact the instructor prior to the anticipated absence for approval to miss the class.
