- ➤ Identify and use appropriate and sufficient scientific evidence to evaluate claims and explanations about the natural and designed world in the context of food and cooking.

ASSIGNMENTS & EXAMS

Three (3) lecture exams, a comprehensive final exam and several Learning Activities will be given during the semester. Make-up exams will be arranged only if the instructor is contacted prior to the scheduled exam time and then only if you present an institutionally valid excuse.

See the posted schedule for Learning Activity due dates, 11:59pm applies to all dates listed. A 5% late penalty, per day, will apply for late submissions, for up to six (6) days. On the seventh day past the due date, a submission will not be accepted. For example, if a Learning Activity is due 11:59pm Monday, Feb. 24, and it is turned in Wednesday, Feb. 26, then a 10% late penalty applies. Beginning 12:00am Monday, Mar. 3, the Learning Activity will not be accepted.
