Successful completion of Organic Chemistry II (CHE2096) or consent of professor is required.

# **Course Description**

Development of significant topics in bioinorganic chemistry particularly those at the interface of chemistry and biology. Emphasis is placed on understanding the role of metals in biological systems such as enzymes and DNA. This is a 2-unit course.

## **Course Learning Outcomes**

At the completion of this course, students will be able to:

- Explain the importance of transition metals in biological systems.
- Define the role of metal ions in various biological systems.
- Describe different instrumental methods used to study the metals in biological systems.

**Grading:** The final grade will be determined as follows:

Letter grades will be assigned according to the following scale: A, 90 - 100%; B, 80 - 90%; C, 70 - 80%, D, 60 - 70%, F, below 60%.

**Prelecture reading quizzes:** A prelecture reading quiz will be available in canvas for each lecture class. The assignment will describe the reading to be completed before the next lecture and ask a few simple questions.

**Problem Sets:** Each chapter will have a problem set due two days after the last lecture of that material.

**Presentation:** Each student will deliver a 15–20 minute presentation discussing aa topic in bioinorganic chemistry. More information will be provided in class.

**Participation:** Various in-class activities will be graded during the semester. These could include discussions, worksheets, etc.

**Exams:** There will be two midterm exams during the semester. The date of the midterm exams will depend on the pace of the class and at least one week notice will be given. The **final exam** (second exam) will be given on the last day of class: March 7.

**Program Learning Outcomes: CHEM PLO 1b**: Students will demonstrate understanding of and apply key concepts and principles of biochemistry. This PLO will be assessed using exams and other graded materials.
