COURSE DESCRIPTION

Students document community activities through still photography and documentary video for student media. May be repeated up to a total of three (3) units.

PLNU ATTENDANCE AND PARTICIPATION POLICY

PLNU COURSE MODALITY DEFINITIONS

- 1) Online Courses: These are courses with class meetings where all instruction and interaction is fully online.
 - a) Synchronous Courses: At least one class meeting takes place at a designated time.
 - b) Asynchronous Courses: All class meetings are asynchronous.
- 2) Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- 3) In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

ASSIGNMENTS AT-A-GLANCE

Photo Assignments (520 points): Students will shoot, edit and submit photography assignments each week. Thirteen assignments will be assessed as complete/incomplete and collectively account for 52% of the final grade.

Participation (260 points): Attendance and tardiness will be marked at the start of each class session to reinforce the importance of in-class engagement. The total value of full attendance is 26% of the final grade.

Research (100 points): Students will use online resources to share resources about specific technical topics related to photography. This research will be assessed as complete/incomplete and collectively account for 10% of the final grade.

Final Presentation (75 points): Students will present a collection of their best work during the final exam time. This will be assessed as complete/incomplete and account for 7.5% of the final grade.

Goals (45 points): Students will set and reflect on goals throughout the semester. These assignments will be assessed as complete/incomplete and collectively account for 4.5% of the final grade.
