PLNU COURSE MODALITY DEFINITIONS

- 1) Online Courses: These are courses with class meetings where all instruction and interaction is fully online.
 - a) Synchronous Courses: At least one class meeting takes place at a designated time.
 - **b)** Asynchronous Courses: All class meetings are asynchronous.
- 2) Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- 3) In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

ASSIGNMENTS AT-A-GLANCE

See Canvas for deadlines and assignment details.

Film Scenes (300 points): Produce five film scenes during the semester to demonstrate how aesthetic techniques impact the effectiveness of the overall scene. Submissions will be assessed using a rubric for a combined total of 30% of the final grade.

Competencies (200 points): Complete weekly skills-based assignments to show proficiency in aspects of cinema camera operation, lighting, color correction, green screen compositing, composition, movement, animation, motion tracking, continuity editing, and montage. Submissions will be assessed using a rubric for a combined total of 20% of the final grade.

Chapter Notes (180 points): Submit notes from the assigned readings using the template provided in Canvas. Your chapter notes will be available as a resource during quizzes. Submissions will be assessed as complete or incomplete for a combined total of 18% of the final grade.

Quizzes (120 points): Complete three open-note quizzes during the semester. Quizzes will be assessed for a combined total of 12% of the final grade.

Final Exam (100 points): The final exam will be assessed for a total of 10% of the final grade.

Attendance (100 points): Attendance and tardiness will be marked at the start of each class session. The total value of full attendance is 10% of the final grade.
