## **COURSE CREDIT HOUR INFORMATION**

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 1-unit, 2-unit or 3-unit class delivered over 15 weeks depending on how many units were selected. It is anticipated that students will spend a minimum of 37.5 participation hours per credit hour on their coursework. For this course, students will spend an estimated 37.5 total hours meeting the course learning outcomes for 1 unit, an estimated 75 total hours meeting the course learning outcomes for 2 units, or an estimated 112.5 total hours meeting the course learning outcomes for 3 units. The time estimations are provided in the Canvas modules.

### PLNU COURSE MODALITY DEFINITIONS

- 1) Online Courses: These are courses with class meetings where all instruction and interaction is fully online.
  - a) Synchronous Courses: At least one class meeting takes place at a designated time.
  - b) Asynchronous Courses: All class meetings are asynchronous.
- 2) Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.

3) In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

### **ASSIGNMENTS AT-A-GLANCE**

See Canvas for deadlines and assignment details.

*Content Creation (200 points):* Students will produce four pieces of content for Point TV's social media channels. Items published by PTV will receive full credit. Submissions that are not viable for publication receive half credit. These projects will be assessed for a total of 20% of the final grade.

*Narrative Short Film (200 points):* Students will contribute to the production of a short film. The group production will be assessed for a total of 20% of the final grade.

*Documentary Short Film (175 points):* Students will contribute to the production of a short documentary film. The group production will be assessed for a total of 17.5% of the final grade.

*Promotional Video (175 points)*: Students will contribute to the production of a short promotional video. The group production will be assessed for a total of 17.5% of the final grade.

Attendance (150 points): Attendance and tardiness will be marked at the start of each class session to reinforce the importance of in-class engagement. The total value of full attendance is 15% of the final grade.

*Hours Log (100 points):* Students will log the production hours they complete in compliance with the required minimum hours per credit unit. Completion of the log will count toward 10% of the final grade.
