Class Presentations: Students will be asked to present to the class entries, travel notes, camping thoughts, sketches, poems, song lyrics, and thoughts from their class journal that deal with a wilderness subject appropriate to what we have been reading and studying. The presentation should promote heightened awareness of nature or wilderness issues along with promotion of specific ways of thinking about nature. The class will discuss student presentations.

Midterm and Final Exam will be essay questions based upon the assigned reading in the class.

1. The English term "Wilderness." Christian-biblical and Classical Traditions

2. Native American Spiritual Traditions and TEK (Traditional Ecological Knowledge). Discuss of *Wisdom Sits in Places*.

Break for MLK Day: (Over long weekend read Winds of Santa Ana: Pilgrim Stories on the California Bight)

3. Discussion of *Winds of Santa Ana* (Be prepared to show the notes of your thoughts on various situations and types of communication depicted in each chapter of the book, especially Christian traditions of geographical-cultural links, physiologos, and the role of pilgrimage, patron saints, and place-names.)

4. Christian Two-Book Tradition of Divine Communication in Early America and the Draw of Beauty in Nature: Cotton Mather and Jonathan Edwards. Discuss *Christian Philosopher* by Cotton Mather and *Ravished by Beauty* about Jonathan Edwards

5. Environmentalism's American Foundations on the Connecticut River. Discuss chapter 1 of Stoll's *Inherit the Holy Mountain*

6. Humboldtian Science and Ecological-Conservational Thinking. Discuss chapter 2 of Stoll's *Inherit the Holy Mountain* along with chapter on Humboldt and Darwin provided on Canvas.

7. Romanticism and Transcendentalism in America: Emerson and Thoreau. Discuss essays by Thoreau and Emerson provided on Canvas

8. Women Science Teachers and the Invention of Hiking Culture. Discuss chapter from *On the Trail* and chapter on *Pioneering Women Naturalists* provided on Canvas

9. The Idea and Design of Gardens, Parks, and Forests: Marsh, Downing, and Olmsted. Discuss chapter 3 of Stoll's *Inherit the Holy Mountain* along with documentary on Olmsted provided on Canvas.

10. Nature, Parks, and Emersonian Modernism. Discuss chapter 4 of Mark Stoll's Inherit the Holy Mountain.

11. William Bartram and John Burroughs: New England's Outsiders. Discuss Mark Stoll's *inherit the Holy Mountain* chapter 7 and writings by William Bartram provided on Canvas.

12. John Muir: Both Scientist and Romantic. Discuss John Muir: Nature Writings pp. 135-170, 219-266.

13. John Muir: Nature Writings pp. 465-499, 618-633, 721-743.

14. Hetch Hetchy, Conservation/Preservation, and the Department of Interior. Discuss writings provided on Canvas.

16. Aldo Leopold, *Sand County Almanac*, and the Wilderness Society. Read excerpts of *Sand County Almanac* and watch videos provided on Canvas.

17. A National Parks System: Gifford Pinchot, Stephen Mather, and Horace Albright. Watch the two Ken Burns documentary episodes linked on Canvas.

18. The Roosevelt Families and Presidential Responsibility. Discuss chapters from the biographies of TR and FDR provided on Canvas.

19. The Johnsons, Stegner's Letter, The Wilderness Act of 1964, Wilderness Trails Act of 1968, and the "National Beauty Address." Discuss the letter and watch the videos provided on Canvas.

20. Rachel Carson and The Nature Study Movement. Discuss Stoll's *Inherit the Holy Mountain* pp. 192-199 and watch the documentary on Carson.

21. Annie Dillard, William Cronon, and Dividing the Natural from the Spiritual. Discuss the excerpts from Dillard and Cronon provided on Canvas.

22. William O. Douglas, Wilderness Bill of Rights, and Eucalyptographia. Discuss Farmer's chapter on Eucalyptus and Douglas on Bill of Rights.

24. The Chumash Marine Sanctuary, Braiding Sweetgrass, and Environmental Humanities. Discuss the three readings provided on Canvas.

PLNU Course Modality Definitions*
