News Stories (350 points): Students will write 10 news stories during the semester for a maximum of 35 points each. When stories are published by The Point, 10 points of extra credit will be awarded. Since spelling and deadlines are critical in journalism, they rate special emphasis in grading. News stories will be assessed for a total of 35 percent of the final grade. Missing a deadline will reduce the total potential score by 10 percent each day it's late.

Chapter Responses (250 points): Students will write 23 responses to assigned book chapters for a maximum of 12 points each. The two lowest scores will be dropped. These responses account for 25 percent of the final grade.

*Quizzes on AP Style (100 points)*: Students will take 10 open-book quizzes on AP Style for a maximum of 10 points each. These quizzes account for 10 percent of the final grade.

*Quizzes on Current Events (100 points):* Students will take 10 in-class quizzes on current events valued at 10 points each. Quizzes will include one bonus question for a maximum potential of 10 points each. These quizzes account for 10 percent of the final grade.

Canvas Assignments (50 points): A series of assignments will be submitted on Canvas to learn introductory concepts in journalism and prepare students to write news stories. These exercises account for 10 percent of the final grade.

Film Presentations (50 points): in groups, students will make a presentation on a journalism-related film from a provided list for a maximum of 50 points. This project accounts for 5 of the final grade.

Extra Credit Film Analysis (35 points): Watch a journalism-related film from the provided list and write a 1- to 2-page analysis. Limit the plot summary to two paragraphs and include at least one full page analyzing the journalism issues based on concepts explored in class. This may be repeated up to three times for a total potential extra credit of 10 percent of the final grade.

#### FINAL EXAMINATION POLICY

Successful completion of this class requires taking the final examination on its scheduled day. The final examination schedule is posted on the <u>Traditional Undergraduate Records: Final Exam Schedules</u> site. If you find yourself scheduled for three (3) or more final examinations on the same day, you are authorized to contact each professor to arrange a different time for <u>one</u> of those exams. However, unless you have three (3) or more exams on the same day, no requests for alternative final examinations will be granted.

#### **CONTENT WARNING**

I acknowledge that each of you comes to PLNU with your own unique life experiences. This contributes to the way you perceive various types of information. In JRN2050 – Introduction to Journalism, all the class content, including that which may be intellectually or emotionally challenging, has been intentionally curated to achieve the learning goals for this course. The decision to include such material is not taken lightly. Topics often covered in the news and that therefore could be covered in our classroom include themes of violence, death, grief, sexual assault and harassment, mental health issues, discrimination, hate crimes, child abuse and neglect, substance abuse, trauma and PTSD, police and state violence, environmental disaster and climate change, as well as many others. If you encounter a topic that is intellectually challenging for you, it can manifest in feelings of discomfort and upset. In response, I encourage you to come talk to me or your friends or family about it. I will do my best to create a safe space for your honest opinions, thoughts and questions. Class topics are discussed for the sole purpose of expanding your intellectual engagement in the area of journalism, and I will support you throughout your learning in this course.

Deadlines for publication are set in collaboration with the editors of The Point. If you miss a deadline and the story is not of sufficient quality to be published, no credit will be given for that attempt.
