Course Schedule

The course schedule below outlines the topics, assignments, and deadlines for each week.

Week 1: Introduction to Multimedia Journalism and Portfolio Building

- **Tuesday:** No Class
- **Thursday:** Overview of multimedia storytelling techniques; introduction to portfolio platforms.
- **Assignment:** Research and critique three professional journalist portfolios.
 - **Due:** Following Tuesday.

Week 2: Writing for Digital Media

- **Tuesday:** Crafting compelling headlines and SEO-friendly content.
- **Thursday:** Workshop: Drafting and peer-reviewing a feature story.
- **Assignment:** Write a 500-word feature story for your portfolio.
 - **Due:** Following Tuesday.

Week 3: Photography and Visual Storytelling

- **Tuesday:** Fundamentals of photojournalism: composition, lighting, and editing.
- **Thursday:** Workshop: Shooting and editing photos; peer review of sample work.
- **Assignment:** Create a photo essay with 5–8 high-quality images.
 - **Due:** Following Tuesday.

Week 4: Audio Storytelling

- **Tuesday:** Basics of audio recording and editing.
- **Thursday:** Workshop: Recording and editing practice; peer review of drafts.
- **Assignment:** Record and edit a 2–3 minute audio story.
 - **Due:** Following Tuesday.

Week 5: Video Journalism

- **Tuesday:** Shooting and editing video for digital platforms.
- **Thursday:** Workshop: Storyboarding and scripting for video; peer feedback on drafts.
- **Assignment:** Produce a 2–3 minute video story, including interviews and B-roll.
 - **Due:** Following Tuesday.

Week 6: Data Visualization and Infographics

- **Tuesday:** Tools for creating data visualizations.
- **Thursday:** Workshop: Creating and refining data visualizations.
- **Assignment:** Create a data visualization or infographic.
 - **Due:** Following Tuesday.

Week 7: Interactive Storytelling

- **Tuesday:** Tools for interactivity.

- **Thursday:** Workshop: Developing interactive elements.
- **Assignment:** Develop an interactive element and integrate it into your portfolio.
 - **Due:** Following Tuesday.

Week 8: Polishing and Personal Branding

- **Tuesday:** Writing an effective bio and creating a professional "About Me" page.
- **Thursday:** Workshop: Revising multimedia elements and creating a cohesive portfolio design.
- **Assignment:** Finalize your portfolio.
 - **Due:** Following Tuesday.

Week 9: Peer Review and Feedback

- **Tuesday:** Conducting constructive peer reviews.
- **Thursday:** Workshop: Revising portfolio based on feedback.
- **Assignment:** Peer reviews due Thursday; portfolio revisions due following Tuesday.

Week 10: Launch and Showcase

- **Tuesday:** Final portfolio presentations: Group 1.
- **Thursday:** Final portfolio presentations: Group 2.
- **Assignment:** Submit final portfolio link by the end of Thursday's class.

STATE AUTHORIZATION

PLNU ATTENDANCE AND PARTICIPATION POLICY

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university drop date or, after that date, receive the appropriate grade for their work and participation.
