GENERAL EDUCATION MISSION

COURSE DESCRIPTION

Instruction in the necessary skills and use of proper equipment for safe, enjoyable wilderness outings. Concepts of survival, route-finding, ropes, equipment, safety and climbing techniques are part of the student's experience.

COURSE LEARNING OUTCOMES

The primary objective of this course is to acquaint students with the knowledge and activities to rock climbing in a safe environment.

PERFORMANCE OBJECTIVES

At the conclusion of the class a student will be able to do the following:

- Demonstrate skill competency in rock climbing at Santee rocks bouldering, rappelling and belaying. Also, indoor climbing experience at Mesa Rim.
- Demonstrate safety in spotting and ropes.
- Demonstrate care of equipment and environment.
- Demonstrate techniques for ropes belay, climber, and rappel.

GENERAL EDUCATION LEARNING OUTCOME

Students will develop an understanding of self that fosters personal well-being.

FINAL EXAMINATION POLICY

STATE AUTHORIZATION

PLNU ACADEMIC ACCOMMODATIONS POLICY

PLNU is committed to providing equal opportunity for participation in all its programs, services, and activities in accordance with the Americans with Disabilities Act (ADA). Students with disabilities may request course-related accommodations by contacting the Educational Access Center (EAC), located in the Bond Academic Center (EAC@pointloma.edu or 619-849-2486). Once a student's eligibility for an accommodation has been determined, the EAC will work with the student to create an Accommodation Plan (AP) that outlines allowed accommodations. The EAC makes accommodations available to professors at the student's request.

PLNU highly recommends that students speak with their professors during the first two weeks of each semester/term about the implementation of their AP in that particular

course. Accommodations are not retroactive so clarifying with the professor at the outset is one of the best ways to promote positive academic outcomes.

Students who need accommodations for a disability should contact the EAC as early as possible (i.e., ideally before the beginning of the semester) to assure appropriate accommodations can be provided. It is the student's responsibility to make the first contact with the EAC. Students cannot assume that because they had accommodations in the past, their eligibility at PLNU is automatic. All determinations at PLNU must go through the EAC process. This is to protect the privacy of students with disabilities who may not want to disclose this information and are not asking for any special accommodations.

PLNU ATTENDANCE AND PARTICIPATION POLICY

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university withdrawal date or, after that date, receive an "F" grade.

Asynchronous Attendance/Participation Definition

A day of attendance in asynchronous content is determined as contributing a substantive note, assignment, discussion, or submission by the posted due date. Failure to meet these standards will result in an absence for that day. Instructors will determine how many asynchronous attendance days are required each week.
