COURSE DESCRIPTION

This course provides advanced study in the essential research of a specific discipline in Kinesiology.

Fundamental skills in reading and evaluating research will be acquired, including examining research paradigms, critically appraising study design and findings, and determining the practical relevance of the results. A directed reading seminar is a course designed for students writing and developing their research project (i.e. thesis, capstone or pilot study) who wish to refine, deepen and complete their review of literature and begin collecting data. Students are expected to have done a good deal of background reading to prepare them for this course and should be well on their way to finishing up the review of literature so that data collection can begin.

4. Serve various populations, integrating compassionate care and the Christian faith with their professional practice.
5. Pursue an active and growing involvement in their discipline by achieving advanced certification and/or membership in a related professional organization.

COURSE LEARNING OUTCOMES (CLO)

1. You will critically appraise various research paradigms, study designs, methodologies, results, and practical relevance of reported findings.

2. You will present and evaluate various research publications in a specific discipline in Kinesiology (i.e., biomechanics, athletic training, motor control, etc.) in regular Journal Club style meetings.
3. You will reinforce your own review of literature for the Introduction, Methods, and Discussion sections of your thesis or capstone project.

CREDIT HOUR INFORMATION

It is anticipated that students will spend a minimum of 50 participation hours per credit hour on their course work. As a graduate course, students can expect the work in this class to be significant, and students should plan on spending 18-22 hours a week engaged in the course. COURSE ASSIGNMENTS

- **Annotated Bibliography:** A 10-12 item annotated bibliography for the thesis. Write your hypothesis statement at the top of the annotated bibliography and for each entry (50-70 words), clarify its relation to your hypothesis. Make sure to include at least 3 sources that oppose your hypothesis. (80 points total)
- **Journal Club:** Each week, you will be required to present a research article, either of your selection or one selected by your advisor to the class in a Journal Club type session. The article needs to be from a peer-reviewed journal and unique each week. (70 points total)
- **Comparative Review:** A 4-page paper stating your hypothesis and a synopsis of one published work supporting the hypothesis and one opposing it. Explain why your hypothesis is important, for what and to whom. Be sure to include alternative explanations of published methods and findings within your thesis topic. (150 points total)

Class topics are discussed for the sole purpose of expanding your intellectual engagement in the area of sports medicine, and I will support you throughout your learning in this course.

TRIGGER WARNING

I acknowledge that each of you comes to PLNU with your own unique life experiences. This contributes to the way you perceive several types of information. In Research Methods, we will cover a variety of topics, some of which you may find triggering. These topics include diagnostic testing, epidemiology, and injury etiology. Each time this topic appears in a reading or unit, it is marked on the syllabus. The experience of being triggered versus intellectually challenged are different. The main difference is that an individual must have experienced trauma to experience being triggered, whereas an intellectual challenge has nothing to do with trauma. If you are a trauma survivor and encounter a topic in this class that is triggering for you, you may feel overwhelmed or panicked and find it difficult to concentrate. In response, I encourage you to take the necessary steps for your emotional safety. This may include leaving class while the topic is discussed or talking to a therapist at the Counseling Center. Should you choose to sit out on discussion of a certain topic, know that you are still responsible for the material; but we can discuss if there are other methods for accessing that material, and for assessing your learning on that material. Class topics are discussed for the sole purpose of expanding your intellectual engagement in the area of sports medicine, and I will support you throughout your learning in this course.

PLNU ATTENDANCE AND PARTICIPATION POLICY

Hybrid Format

At Point Loma Nazarene University, attendance is required at all scheduled classes. Adult Degree Completion courses are taught in the hybrid format, which means some class meetings will be face-to-face and some will be online.

Attendance in the face-to-face classes is to be for the entire time of the class. Arriving late or leaving early will be considered a partial absence. A day of attendance in an online class is determined as contributing a substantive note, assignment, discussion, or submission that adds value to the course as determined by the instructor. Three days of attendance are required each week. (It may be any three days during the week.)

Face-to-face Portion of the Hybrid course

In blended or hybrid courses, if a student misses one face-to-face class then the faculty member will send an email to the student and the Director of Student Success warning of attendance jeopardy. There are no exceptions to this policy.

If a student misses two face-to-face classes, the faculty member or Vice Provost for Academic Administration (VPAA) will initiate the student's de-enrollment from the course without further advanced notice to the student. If the date of de-enrollment is past the last date to withdraw from a class, the student will be assigned a grade of "F" and there will be no refund of tuition for that course.

Online Portion of the Hybrid Course

If a student misses two online classes (fails to contribute to a discussion board) during the course, then the faculty member will send an email to the student and the Director of Student Success warning of attendance jeopardy. There are no exceptions to this policy.

If a student misses three online classes (fails to contribute to a discussion board by the due date) during the course, then the faculty member or Vice Provost for Academic Administration (VPAA) will initiate the student's de-enrollment from the course without further advanced notice to the student. If the date of de-enrollment is past the last date to withdraw from a class, the student will be assigned a grade of "F" and there will be no refund of tuition for that course.

1 missed F2F class = warning

2 missed online classes = warning

3 missed online classes = de-enrollment

Online Format

Students taking online courses are expected to attend each week of the course. Attendance is defined as participating in an academic activity within the online classroom which includes posting in a graded activity in the course. (Note: Logging into the course does not qualify as participation and will not be counted as meeting the attendance requirement.)

Students who do not attend at least once in any 3 consecutive days will be issued an attendance warning. Students who do not attend at least once in any 7 consecutive days will be dropped from the course retroactive to the last date of recorded attendance.

Asynchronous Attendance/Participation Definition

A day of attendance in asynchronous content is determined as contributing a substantive note, assignment, discussion, or submission by the posted due date. Failure to meet these standards will result in an absence for that day. Instructors will determine how many asynchronous attendance days are required each week.
