#### **Course Description**

This course introduces analyzing data and designing research experiments in occupational therapy. Topics include selected techniques and designs used in research, with special emphasis given to planning, conducting, and reporting of research, and applied statistical analysis and interpretation of data from the field of occupational therapy.

Prerequisite(s): Successful completion of OCC 6003.

Successful completion of this course is necessary to progress to OCC 6024.

### **Relationship of Course to Curriculum Design**

This course is the 2<sup>nd</sup> in a 3-part series on providing evidence-based OT services. It is taken concurrently with the following courses: OCC 6007 (Human Occupations Across the Lifespan); OCC 6008 (Applied Human Movement): ANA 6009 (Applied Neuroanatomy); OCC 6011 and OCC 6011L (Mental Health Conditions, Assessments, and Interventions and Lab), and OCC 6012 (Case-Based Learning Seminar-II). This course supports the curricular thread of occupation. The foundational knowledge gained in the course prepares students to succeed in all OT coursework, and particularly in OCC 6024, Research Methods-2 course.

### **Program and Course Learning Outcomes**

A research project is not required for this Standard, and narrative reviews do not meet this Standard (B.6.1)

- Demonstrate an understanding and use of quantitative and qualitative methods for data analysis to include basic descriptive, correlational, and inferential quantitative statistics. Analysis and synthesis of qualitative data (B.6.2).
- 5. Demonstrate the skills necessary to write a scholarly report in a format for presentation or publication, which may be made available to professional or public audiences (B.6.3).
- 6. Demonstrate an understanding of the process of locating and securing grants and how grants can serve as a fiscal resource for scholarly activities and program development (B.6.4).
- 7. Demonstrate an understanding of the ethical policies and procedures for human subject research, educational research, or research related to population health (B.6.5).

# **Grade Intervention Plan**

Scoring below a letter grade of a C (73%) in any didactic course is not considered to be a passing grade.

# **Trigger Warning**

I acknowledge that each of you comes to PLNU with your own unique life experiences. This contributes to the way you perceive several types of information. In Research Methods-1 we will cover a variety of topics, some of which you may find triggering. These topics include the need to obtain informed consent due to historical issues of not obtaining informed consent from study participants. Each time this topic appears in a reading or unit, it is marked on the syllabus. The experience of being triggered versus intellectually challenged are different. The main difference is that an individual must have experienced trauma to experience being triggered, whereas an intellectual challenge has nothing to do with trauma. If you are a trauma survivor and encounter a topic in this class that is triggering for you, you may feel overwhelmed or panicked and find it difficult to concentrate. In response, I encourage you to take the necessary steps for your emotional safety. This may include leaving class while the topic is discussed or talking to a therapist at the Counseling Center. Should you choose to sit out on discussion of a certain topic, know that you are still responsible for the material; but we can discuss if there are other methods for accessing that material and for assessing your learning on that material. Class topics are discussed for the sole purpose of expanding your intellectual engagement in the profession of occupational therapy, and I will support you throughout your learning in this course.

# **PLNU Course Modality Definitions**

- 1. Online Courses: These are courses with class meetings where all instruction and interaction is fully online.
  - a. Synchronous Courses: At least one class meeting takes place at a designated time.
  - b. Asynchronous Courses: All class meetings are asynchronous.
- 2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- 3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

# PLNU Attendance and Participation Policy

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. Therefore, regular attendance and participation in each course are minimal requirements.

If the student is absent for more than 10 percent of class sessions, two classes for a 16-week course and 1 class for a quad course, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university withdrawal date or, after that date, receive an "F" grade.
