COURSE DESCRIPTION

In this course, we will be reading and discussing works of fiction, poetry, and creative non-fiction that address the natural world and our role in it in order to gain an understanding of "human endeavors from a historical, cultural, linguistic, and philosophical perspective, including developing a critical appreciation of human expression--both artistic and literary."

Reading Quizzes	Each module you will take a proctored reading quiz composed of 10 questions regarding the texts for the week. These questions are not designed to be "trick questions" but rather to ensure you are prepared to discuss the readings in our Class Discussions and Reading Reflections.	10%		
Class Discussions	Each module you will engage in one class discussion based on the texts for that week. For your initial post, you will choose from one of several prompts and compose a one-paragraph response. You will then reply to another student who chose a different prompt from you, furthering the discussion.	25%		
Reading Reflections	Each module you will compose a short, one-page essay in response to a prompt based on one or more of that week's texts. These reflections are a bit more detailed than the discussion prompts, involving additional critical thinking, and may ask you to draw connections to previous content in the course.	30%		
Peer Reviews	In each module, on Friday morning, you will be assigned two of your peers' reading reflections to review. You will submit a brief, yet structured peer review for both of these reflections. These reviews are designed to allow you to help your peers and to help you refine your review skills so that you can more effectively edit and revise your own work.	10%

Synchronous Attendance/Participation Definition

Online Asynchronous Attendance/Participation Definition

Students taking online courses with no specific scheduled meeting times are expected to actively engage throughout each week of the course. Attendance is defined as participating in an academic activity within the online classroom which includes, but is not limited to:

- Engaging in an online discussion
- Submitting an assignment
- Taking an exam
- Participating in online labs
- Initiating contact with faculty member within the learning management system to discuss course content

Note: Logging into the course does not qualify as participation and will not be counted as meeting the attendance requirement.

COURSE MODALITY DEFINITIONS

- Online Courses: These are courses with class meetings where all instruction and interaction are fully online.
 Synchronous Courses: At least one class meeting takes place at a designated time.
 - 2. Asynchronous Courses: All class meetings are asynchronous.
- 2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- 3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).
