**Course Description**

A survey of psychology as an empirical/behavioral science. Topics include biological correlates of behavior, learning, cognition, emotion, motivation, personality, assessment, development, psychopathology, psychotherapy, and social psychology. ### Content Warning

I acknowledge that each of you comes to PLNU with your own unique life experiences. This contributes to the way you perceive various types of information. In General Psychology (PSY 1003), all of the class content, including that which may be intellectually or emotionally challenging, has been intentionally curated to achieve the learning goals for this course. The decision to include such material is not taken lightly. These topics covered in the course from the Myers et al. course textbook include, but are not limited to, Chapter 12: Emotions, Stress, and Health; Chapter 13: Social Psychology; and Chapter 15: Psychological Disorders. If you encounter a topic that is intellectually challenging for you, it can manifest in feelings of discomfort and upset. In response, I encourage you to come talk to me or your friends or

family about it. Class topics are discussed for the sole purpose of expanding your intellectual engagement in the area of General Psychology, and I will support you throughout your learning in this course.

### **Trigger Warning**

I acknowledge that each of you comes to PLNU with your own unique life experiences. This contributes to the way you perceive several types of information. In General Psychology (PSY 1003), we will cover a variety of topics, some of which you may find triggering. These topics covered in the course from the Myers et al. course textbook include, but are not limited to, Chapter 12: Emotions, Stress, and Health; Chapter 13: Social Psychology; and Chapter 15: Psychological Disorders. Each time this topic appears in a reading or unit, it is marked on the syllabus with “\*”. The experience of being triggered versus intellectually challenged are different. The main difference is that an individual must have experienced trauma to experience being triggered, whereas an intellectual challenge has nothing to do with trauma. If you are a trauma survivor and encounter a topic in this class that is triggering for you, you may feel overwhelmed or panicked and find it difficult to concentrate. In response, I encourage you to take the necessary steps for your emotional safety. This may include leaving class while the topic is discussed or talking to a therapist at the Counseling Center. Should you choose to sit out on discussion of a certain topic, know that you are still responsible for the material; but we can discuss if there are other methods for accessing that material, and for assessing your learning on that material. Class topics are discussed for the sole purpose of expanding your intellectual engagement in the area of General Psychology, and I will support you throughout your learning in this course.

### **Incompletes and Late Assignments**

All assignments are to be submitted/turned in by the dates noted in the syllabus for when they are due—including assignments posted in Canvas. Incompletes will only be assigned in extremely unusual circumstances.

Late work is accepted for 10 days, including weekend days, after the original due date. 5% will be deducted from the grade for each late day. For example, an assignment submitted 3 days late can earn up to 85% of the available points. End-of-semester assignments may not be submitted late after the final exam (to accommodate faculty grading deadlines). In other words, no coursework will be accepted after May 6th, 2025 at 11:59 p.m. Work submitted late may also be graded later.

**Course Modality Definitions**

1. Online Courses: These are courses with class meetings where all instruction and interaction is fully online.
  - a. Synchronous Courses: At least one class meeting takes place at a designated time.
  - b. Asynchronous Courses: All class meetings are asynchronous.
2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.

### **Assignments At-A-Glance:**

#### **Weekly Reading Question Responses (10 points each):**

Each week students will read the assigned chapter from the Myers et al. textbook and submit a 250-word response to the question provided in the Canvas Module for that week.

#### **Quizzes 1 and 2 (25 points each):**

Two times throughout the semester, students will take a quiz that will test them on the material they have learned in class and in readings. Details will be provided by the instructor throughout the course.

#### **Midterm Paper (50 points):**

Students will write a “compare and contrast” paper on a topic they will select from a list provided by the instructor during the course. Students will write a 5-page paper (APA or MLA format, double-spaced, 12-point font) in which they will identify 4 peer-reviewed sources related to their chosen topic. The goal of this paper is to present two different views on a psychological concept and to compare and contrast those views. The instructor will provide further details throughout the course, and a detailed rubric for the midterm paper will be posted in Canvas. The Midterm Paper will be due Week 7 on Friday (02/28) at 11:59 pm.

#### **Psychology and You Assignment (8 points):**

Write an essay explaining how insights from psychology can tell you more about yourself, other people, or your relationships. In your essay, be sure to...

- Choose three concepts from this course that involve you or your life in some way (e.g., depression, stress, cognition, etc.). Define them in your own words. Explain why you chose to include each of those three concepts. Be sure to discuss how each concept affects you/your life on a personal level.
