GENERAL EDUCATION MISSION

COURSE DESCRIPTION

A survey of psychology as an empirical/behavioral science. Topics include biological correlates of behavior, learning, cognition, emotion, motivation, personality, assessment, development, psychopathology, psychotherapy, and social psychology. Students should take PSY 1003 if they do not meet the criteria for PSY 1001.

Prerequisite(s): PSY 1001 (may be taken concurrently)

COURSE CREDIT HOUR INFORMATION

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 3 unit class delivered over 16 weeks. It is anticipated that students will spend a minimum of 37.5 participation hours per credit hour on their coursework. For this course, students will spend an estimated 112.5 total hours meeting the course learning outcomes. The time estimations are provided in the Canvas modules.

***TRIGGER WARNING**

I acknowledge that each of you comes to PLNU with your own unique life experiences. This contributes to the way you perceive several types of information. In PSY1001, we will cover a variety of topics, some of which you may find triggering. These topics include suicide, abuse, substance use, and some sexual content. Each time this topic appears in a reading or unit, it is marked on the syllabus. The experience of being triggered versus intellectually challenged are different. The main difference is that an individual must have experienced trauma to experience being triggered, whereas an intellectual challenge has nothing to do with trauma. If you are a trauma survivor and encounter a topic in this class that is triggering for you, you may feel overwhelmed or panicked and find it difficult to concentrate. In response, I encourage you to take the necessary steps for your emotional safety. This may include leaving class while the topic is discussed or talking to a therapist at the Counseling Center. Should you choose to sit out on discussion of a certain topic, know that you are still responsible for the material; but we can discuss if there are other methods for accessing that material, and for assessing your learning on that material. Class topics are discussed for the sole purpose of expanding your intellectual engagement in the area of psychology, and I will support you throughout your learning in this course.

PLNU ATTENDANCE POLICY

You are allowed 2 absences from classes without penalty. For each absence above 2 absences you will lose 5 points from your course grade. The only excused absence occurs when you miss class due to a college-sponsored activity (approved in writing by the Academic Dean). Excused absences for serious illness (hospitalization) and other calamities are up to the discretion of the section professor.

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. If the student is absent for more than 10 percent of class sessions (3 absences), the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent (6 absences), the student may be de-enrolled without notice until the university withdrawal date or, after that date, receive an “F” grade. CHAPTER QUIZZES (10 points each, 150 points total):

PRESENTATION (100 points):

- Presentations will be done in groups of 2-3

- Presentations will apply the concepts from the chapter to an example(s) from culture, art, media, history, etc.*
- Presentations will be 10-15 minutes each and will be done in class every 4 chapters.

FINAL PAPER (100 points):

- In place of a final exam, there will be a final paper.*
- Paper will be due by the end of the scheduled time for our final exam during finals week.
